Apr. 3, 1860. Annual Town Meeting, agreeable to this notice posted by the Clerk and the Constable Stephen Pahnd on the 21st day of March A.D. 1860. The Citizens legal voters of the Town of Chaska, County of Carver and State of Minnesota met at the School House in the City of Chaska aforesaid on the 3rd day of April A.D. 1860 for the purpose of holding their Annual Town Meeting and electing five County Commissioners in pursuance of the New Town law organisation Meeting called to order by the Clerk at eleven o'clock A.M.

John Karcher chosen Moderator by acclamation, Charles Gebhard being absent, Adam Am Rhein was chosen to act as Judge of Election in his place. Oath administered to the Moderator, Judges and Clerks by T.D. Smith Justice of the Peace. Present; Gustave Dressel Chairman Frank Missler, Supervisor, Adam Am Rhein, John Karcher, G. Krayenbuhl Clerk. At half past eleven proceeded to Ballot for the following officers to Wit;

Five County Commisinnors , Three Supervisors, one to be designed as Chairman, One Town Clerk, One Assessor, One Town Treasurer, Two Justice of the Peace, Two Constables, Six Overseers of the Highway. One Overseer of the Poor.

On motion coming before the Board and the Voters being not ready to cast their votes, Gustave Dressel made a motion to adjourn until one o'clock P.M., passed.

In pursuance to the adjournment the Poll was open at 15 minutes past one o'clock P.M. Motion made by Jacob Beihofer to Elect the Overseers of the Highways by acclamation and seconded by John Neunsinger and F. Theis, motion lost. Motion by Jacob Beihofer to reconsider his motion and seconded by Frederick Greiner, lost again. Motion by Ezekiel Ellsworth to hear the report of the Board of Supervisors on account of the expenditures of the Town for the past year, accepted After the hearing of the report of the expenditures of the Town for the last year presented by the Clerk and read by the Chairman, Mr. E. Ellsworth made a motion to raise for the current year the sum of \$400 for expenses for repairing the Roads and Bridges, seconded by John Koch and accepted.

Motion by E. Ellsworth that the Supervisors not issue any more Town orders, seconded by John Neunsinger. Amendment made by Gustave Dressel that the Supervisors be authorized to deliver Certificates to the persons working for the Town for the amount of their Taxes not negotiable, and only for the proper use of the Taxes payers working for the Town. After a motion made by Jacob Slicher to reconsider the amendment, the motion of E. Ellsworth, amended by Gustave Dressel passed. Motion made by Jacob Beihofer to vote for the orders of the Highway Supervisors be by acclamation for the barrow that part of the people, did not pass, the overseers of the highways on his ticket, motion seconded and passed.

Motion of Jacob Beihofer to remove for the next Town meeting to Poll from Chaska to Pine District School House, motion seconded and passed. Motion of Ezekiel Ellsworth to reconsider the motion of Jacob Beihofer to remove the Poll from Chaska to Pine District School House, motion is adopted. Motion made by E. Ellsworth that the Poll for the Town of Chaska shall not be removed before one year from this date, motion seconded and adopted by acclamation.

Poll closed at 5 o'clock P.M. due notice having been given thirty minutes before said hour. Moderator, Clerks and Judges then proceeded to canvass the votes publicly and continued without interruption until done, and the results read by the Clerk which was as follows to Wit;

The following notice was this day received by the Carver County Auditor; notify you that on the 2nd day of September A.D. 1863 a resolution was passed by the Board of Commissioners of Carver County ordering an election be held in Chaska and Carver Town at the time of holding the annual general election for 1863, to decide whether a part of said Town consisting of Township 115 North of Range 24 West shall receive a separate Town Organization under the name of Liberty, those desiring the aforesaid division once organization to vote "Yes" and those opposing said organization to vote "No". The aforesaid order was made in accordance with a petition signed by numerous voters of said Township 115 Range 24.

Nov. 3, 1863. Pursuant to law the voters of said Town met in the School House in the village of Chaska at 9 o'clock A.M. Ezekiel Ellsworth and John Mann were duly qualified as judges of election, and the voters present in consequence of the absence of Mathias Goetz, elected Ferdinand Theis as one of the Judges of said election who duly qualified and ~~was~~ upon was discharged of the duties of said election. J. A. Sargent and Ferdinand Wolff were duly qualified as Clerks of said election. The oath and receipts of the above Judges and Clerks on file. The meeting having been duly organized, then proceeded to vote for the here in after mentioned officers, and likewise upon the separate organization of Township 115, Range 24 under the name of the Town of Liberty by virtue of a resolution of the Board of County Commissioners commission of said County passed September 2, 1863. At the hour of 5 o'clock of said day the polls were closed, after which they were duly canvassed by the said Board and the following is the results of said election as appears by the officers returns on file in this office. Total votes cast 116 of which 114 voted for said organization, and 2 votes against. The Judges of the election appointed Ezekiel Ellsworth one of the Judges to carry the certified election returns to and deliver the same to the County Auditor.

Resolved that the Supervisors of the Town of Chaska be requested to ascertain the indetbedness of said Town any request the Town Supervisors of the Township of Liberty to assess that portion of said Town of Liberty which formerly belonged to Chaska for the purpose of paying their part of said indetbedness.

Voted to allow horses, cattle and mules to run at large in the public highway during the coming year. Voted that hogs, pigs & sheep be prohibited from running at large in said Town for the present year, and pay a fine of 5 dollars for each offence. voted to raise 100 dollars as a special tax to be expended for road and bridges. Voted that a tax of 3 mille levy on the taxable property in said Town be assessed to deppay the expenses in said Town for the current year. Voted to establish 1 Pound for said Town, and John Humple was duly elected Pound Master for said Town, and that the barn of the said John Humple be used as the Pound for said Town.

At 5 o'clock P.M. the Polls were declared closed, and the Judges of the election proceeded to count the votes given for the various town officers and after said canvass declared the following persons elected for the ensueing year to wit;

Voted that all fences in said Town shall be 4½ feet high, Voted that horses, cattle, asses and mules be allowed to run at large. Voted that hogs be prohibited from running at large in said Town for the ensueing year. Voted that sheep be prohibited from running at large in said Town for the ensueing year. Voted the penalty for violating any of the by-laws be 10 dollars for each offences, and the penalty to be applied to the Cheska School District No. 5

Voted that the sum of 150 dollars be levied on the taxable property in said Town for the repair of roads and bridges for the ensueing year.
